

Breeding Terms 2018

1. **The breeding season begins on February 1st and ends on August 31st**
2. **Only healthy mares with vaccination certificate are accepted for breeding.**
Each mare must be accompanied by a health certificate stating that she is free of communicable diseases.
Mares coming from a stable where viral abortion has occurred during the last 12 months cannot be boarded at our stud and will not be bred. Owners who bring such mares will be held liable.
3. **A cervical swab not older than 21 days must be shown at the mare's arrival.**
If this has not been done, the examination will be made at our stud and charged to the mare owner's expense.
4. **The board per day is:**

for mares without foal	Euro	15,- (plus tax 7%)
for mares with foals	Euro	18,- (plus tax 7%)

All stallions are SCID-free.

For frozen semen please call for our contractual documents.

6. The remainder and all incurred vet costs are due when the mare is collected. Any advance payments will be deducted. In order to receive a breeding certificate, the mare owner must produce a copy of the mare's pedigree. The breeding certificate will only be handed over when the full fee has been paid.
7. **All breeding come with a LIVE FOAL GUARANTEE.** If the mare should remain barren, slip or lose the foal or produce a non-viable foal, she is entitled to a free breeding in the following season. Boarding and extra costs will be charged separately. This guarantee expires, if a born foal has completed his first week. If any of the stallions should no longer be available for breeding for whatever reason, the mare owner can choose another stallion of the stud and has to pay the possible additional price. Further claims of the mare owner do not exist.
8. **Any veterinary examinations or treatments are charged to the mare owner's expense.**
Shoeing, training, watches and other extra services will be charged separately.
9. **All due precautions and all possible care will be taken to ensure the well being of visiting mares and foals,** but the stallion owner will not accept responsibility for death, damage or inferiority of the visiting horses whatever reason, not for any accident that occur during breeding.

10. The liability for mares and foals lies with the legal owner as defined by the BGB and is held liable in accordance with the BGB.
11. These general conditions will be given to the mare owner or his representative upon arrival of the mare.
They are considered binding with the arrival of the mare at our farm.
12. German Law applies to this contractual relationship. The place of fulfilment and Jurisdiction is Landshut/Munich
